**Project Description**

The project will provide sanitary sewer service to the Clearview Mobile Home Court by extending a sanitary sewer from West Park Avenue to the mobile home court following Mad Creek. The existing mobile home court wastewater treatment system is in violation of the requirements of the National Pollutant Discharge Elimination System (NPDES) permit. In addition to providing reliable sewer service to the mobile home park, the sewer extension will provide opportunities for development along the Mad Creek corridor.
