INTRODUCTION:

The City of Muscatine has received bids for the Musser to Wiggins Road Trail that was let by the IowaDOT on March 21, 2017. The summary of the contractor's bids on this project is attached

BACKGROUND:

The engineer's estimate for this project is \$1,300,000.00. Seven bids were received. The apparent low bidder is Illowa Investment, Inc. from Blue Grass Iowa \$1,198,197.30.

The bid has been reviewed by the city and the IowaDOT and no unbalanced bid prices are apparent. No exclusions are listed for the apparent low bidder.

RECOMMENDATION/RATIONALE:

The IowaDOT and the city engineer recommend awarding the Trail Project to Illowa Investment, Inc.
