Re: Request Approval of Refuse Collection Services Contract Addendum between the City of Muscatine and Fruitland

Introduction:

The City of Muscatine and City of Fruitland have been in a contract agreement for services provided by the City of Muscatine's Refuse Collection for refuse and recycling collection in Fruitland, Iowa since spring 2009. The City of Muscatine is adding curbside recycling with the use of a vendor, Allied Waste to provide collection services of recycling. Muscatine and Fruitland will both receive this service.

Background:

The City of Fruitland requested proposals from several private haulers and the City of Muscatine in the spring of 2009. The City of Muscatine received the contract and entered into a 28 E Agreement contract with the City of Fruitland in June 2009 for the first contract. The current contract ends on June 30, 2011.

Due to changes in the upcoming services and cost for the remainder of the contract, both councils request an addendum for approval. The addendum has the additional curbside recycling collection services by Allied Waste, a subcontractor of the City of Muscatine and the cost change per month. Fruitland currently pays \$18.25 per household and will begin paying in April 2011 \$20.00 per month. A new contract will be established and begin on July 1, 2011 for the upcoming fiscal year.

Recommendation:

It is staff's recommendation that the City of Muscatine and City of Fruitland enter into the addendum for changes in recycling services and cost for the current contract that is from July 1, 2010 – June 30, 2011.

The City of Fruitland has approved this addendum on February 8, 2011 at the City of Fruitland's council meeting.
